- UPPER AGE LIMIT (as on date of interview) will be 33 years.

  - Age relaxation for Orthopaedic/ Physical Handicapped (OPH) candidates up to a maximum period of 5 years for UR, 8 years for OBC and 10 years for SC/ST category candidates.
- Qualification: MBBS degree from a recognized University/Institute.
- APPLICATION FEE
  - UR & OBC: - RS. 1 000/-
  - No Fees required for SC/ST/PWD/Women candidates
