**CORRIGENDUM**

With reference to tender no: AIIMS/Pat/Tender/LabFurniture/3574 dated 24/10/2017, regarding Setting up Laboratories in various departments of AIIMS Patna, a pre-bid meeting was held on 31/10/2017 in committee hall, medical college building, AIIMS Patna

1. The price bid format for all the departments including central lab facilities may be prepared in the format Annexure-1A.
2. Under the heading 'under bench cabinets' of requirement of pathology Department at pg no 16 of the tender for lab furniture the quantity of the same may be read as '4 under bench cabinets for each Side wall tables/ C-frames/ Wall-benches (item 1 of the table on the page) and 1 for each side tables (item no 2 of the table on the page.)
3. Regarding the requirement of Anatomy lab at pg 17 of the tender document, item no. 2, 3, 5, 6 and 7 , the thickness of the MOC should be read as 'minimum thickness of the GI sheet should be 1.2 mm.
4. Regarding the requirement of Microbiology UG lab 1 at pg 17 of the tender document, item no. 3 (island sink bench), the number of sink per unit item should be read as " 2 per island sink bench'.
5. Regarding Physiology department lab requirements detailed specification of wall mount instrument cabinet I and II and overhead cabinets at pg no 40-41 of the tender document, read ' the Thickness of the MOC (GI sheet) should be a minimum of 1.2 mm'.
6. Regarding Microbiology department lab requirements detailed specification of under bench cabinets, read 'the thickness of the MOC (GI sheet) should be minimum 1.2 mm'.
7. The last date of submission of tender documents may be extended up to 04-12-2017, 14.00 hrs and to open on 04/12/2017 at 15:30 hrs.
