Written Test: 10:00 am to 11:00 am

Interview: 11:00 am onward

- 1. On the day of written test and interview candidates will be required to be present "in person" along with a signed hard copy of application and all required valid ORIGINAL documents (like Identity proof, age proof, degree(s), mark-sheets, council registration documents, degree and experience etc. & one set of self-attested copy of these documents. No extension of time on the day of test and interview will be given to them for this purpose.
- 2. No TA/DA will be paid for appearing in the written test & interview. Those who are in employment must submit a "NO OBJECTION CERTIFICATE" from the employers at the time of appearing before the Selection Committee.
- 3. Candidates applying under any of the reserved category viz. SC/ST/OBC/PH [PWD] will be considered subject to submission of Caste / PH [PWD] Certificate on a prescribed format issued by the competent authority recognized by Govt. of India. OBC candidates should not belong to Creamy Layer. Their sub-caste should be tallied with the Central List of OBC (non-creamy Layer) failing which their candidature will not be considered under the applied reserved category and will be treated as UR/Gen. Category.
- 4. Being called for the written as well interview does not essentially declare the eligibility of the candidate for the post.
- 5. The candidate must ensure that they fulfil eligibility criteria and that the particulars furnished by the applicant are correct in all aspect. If at any stage it is found that the candidate had furnished incorrect information or has suppressed material fact(s), his/her candidature will stand cancelled. If any of these shortcoming(s) is/are detected even after the appointment, his/her services will be summarily terminated as well as other necessary administrative, financial, and / or legal proceedings will be initiated. In other cases also where anything is detected at any stage of selection or employment, which undermines the eligibility of the candidate on any account; his/her employment is liable for termination.
- 6. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 7. Canvassing in any form will be treated as absolute disqualification.
- 8. During any stage of selection or even after appointment, if the information provided by the candidate viz. including Education, Experience etc.is found to be incorrect his/her selection will be treated as null and void ab initio.

## **Important Note:**

1. This may be treated as INTIMATION to all eligible candidates for Group- 'A' posts scheduled for written test and interview to be held on 23<sup>rd</sup> December 2017 as mentioned above.
