Walk-in Interview for Senior Residents/ Junior Residents/

- I. **UPPER AGE LIMIT (AS ON date of interview) - 33 years,**
Relaxable for SC/ST candidate upto a maximum period of five years, in the case of OBC candidates upto a maximum period of three years. (ii) In the case of Orthopaedic / Physical Handicapped (OPH) candidates upto maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates. (iii) 5 years for those who are already appointed as Senior Residents / Tutor / and possessing DM/M.Ch qualification. The age limit is relaxable by 5 years for SC/ST candidates and 3 years for OBC candidates.
- II. **APPLICATION FEE:**
UR/Gen & OBC : Rs.1000/-
SC & ST : Rs. 800/-
(Physically handicapped (eligible as per eligibility criteria under Govt, of India rules) candidates are exempted from paying application fees).
- III. The fee shall be received in the form of Demand Draft/Drawn in favour of "**Director, AIIMS Patna**" payable at Patna. (Application Fee will be received on the day of Interview)
- IV. The candidates required to be present 'in person' along with application form duly filled with supporting documents and original certificates (DOB, MBBS Degree, Registration certificate from MCI/State Medical Council/DMC, PG degree/Pass certificate, MD/MS/DNB/Ph.D., valid SC/ST/OBC certificate(if applicable) , NOC from the present employer (Applicable for those working in Govt. organization)OBC – Certificate should be valid for Government of India employment.
- V. Senior Resident(s) : A postgraduate degree viz. MD /MS in concerned subject from a recognized University/Institute.

Junior Resident (s) : M.B.B.S Degree from a recognized University/Institute.
